Should additional origin switching be required, a \$30 per car charge would be assessed and demurrage would apply on all loaded cars not billed, as per TCWR / MPLI 8400 series tariff's. **Rates are subject to TCWR Fuel Surcharge Tariff 9020 series.** TCWR maximum gross weight 268,000 lbs. and MPLI maximum gross weight 263,000 lbs.
