Demurrage at destination will be assessed as per CN 9000. **CAR ORDER MUST BE PLACED SEVEN (7) DAYS PRIOR TO REQUESTED PLACEMENT DATE. Rates are in U.S. Funds. The maximum gross weight on cars loaded on the TC&W is 268,000 lbs and 263,000 lbs on the MPLI. Rates are subject to TCWR Fuel Surcharge Tariff 9020 series.**
