**Shipping Conditions:**

**Rates** apply only on shipments loaded in railroad owned or leased covered hopper cars. **Rates** are not subject to diversion, inspection, re-consignment, or transit privileges. Should additional origins switching be required, a \$30 per car charge would be assessed and demurrage would apply on all loaded cars not billed, as per MPLI Tariff 8400 series. **CAR ORDER MUST BE PLACED SEVEN (7) DAYS PRIOR TO REQUESTED PLACEMENT DATE.** Rates are in U.S. Funds. Rates are applicable in cars not exceeding maximum gross weight limit of 263,000 lbs.

**(A) Shipments** may be accumulated from more than one (1) origin but not more than three (3) origins from Arlington, MN to Fairfax, MN, plus a charge of \$30.00 per car if from more than one (1) origin.

**(B) Shipments** may be accumulated from more than one (1) origin but not more than two (2) origins from Morton to Wood Lake, MN, plus a charge of \$30.00 per car if from more than one (1) origin.

**Shipments loaded under the provisions in (A) cannot be co-loaded with shipments loaded under the provisions in (B).** Rates on 10 or 25 car blocks apply only when receivers can accept all cars in a single switch.

\*Husky plant at Lloydminster will be the tariff rate plus \$185 per car for interswitch fees.

**Note 1** – Arlington, Winthrop, Gibbon, Fairfax, Morton, Redwood Falls, Delhi, Echo, and Wood Lake, MN.
